The MDA is an Individually Managed Account (IMA) and clients will have different results depending on their holdings. To find the performance we have got one of the earliest accounts that has been established during the 1 and 3 year period for each strategy and used those results. Whilst most of the clients will be similar it is dependent on the composition of the IMA.

The Harbourside Investment Management Managed Accounts focuses on having a diversified portfolio of non correlated assets. This should hold the portfolio in good stead when the equity markets are selling off. Pleasingly this has been the case as indicated by the numbers below.
